Applicant further avers:

- (1)

That he is a person of good character and reputation, and over 18 years of age; and he is the full and only owner of the business for which this permit is sought.
- (2)

That he is a citizen of the United States and of the State of Louisiana, and a resident of the Parish of Vermilion continuously for a period of two years.
- (3)

That he is the owner of the premises or has a bona fide written lease therefore-in proof hereof, he attaches a certified copy of his deed or lease hereto.
- (4)

That he has not been convicted of a felony under the laws of the United State, the State of Louisiana, or any state.
- (5)

That he has not been convicted in this state or in any other state or by the United States of soliciting for prostitution, pandering, letting premises for prostitutes, contributing to the delinquency of juveniles, keeping a disorderly house, letting a disorderly place or dealing in narcotics.
- (6)

That he has not had revoked a license or permit to sell or deal in alcoholic beverages issued by the United States or any other state, or parish, for 5 years prior to this application, or been convicted or had judgment against him involving alcoholic beverages by this parish, state, or any other state, or the United States for 5 years prior to this application.
- (7)

That he has not been adjudged by the Alcoholic Beverage Control Board, or any other board or convicted by any court of this State of violating any of the provisions of “The Alcoholic Beverage Control Law” (La. R.S. 26:1 et seq).
- (8)

That he has not been convicted of violating any municipal or parish ordinance adopted pursuant to “The Alcoholic Beverage Control Law” of Louisiana (La. R.S. 26:1 et seq).

- (9) That he is not the spouse of a person whose application has been denied or whose permit has been revoked, unless judicially separated or divorced.
- (10) That he is not an “interposed person” as defined by La. R.S. 26:81; that is to say that he is not subsidized, financed or employed by another person or group or persons who are owners or proprietors of this business and who are not named on this application.
- (11) That he is familiar with and will abide by and observe and take affirmative action to prevent any violations of the requirements of La. R.S. 26:88; which reads;

“No persons holding a retail dealer’s permit and no agent associate, employee, representative, or servant of any such person shall do or permit any of the following acts to be done on or about the licensed premises:

- (1) Sell or serve alcoholic beverages to any person under the age of eighteen years.
- (2) Sell or serve alcoholic beverages to any intoxicated person.
- (3) Invite or permit any person under the age of eighteen years to visit or loiter in or about any place where alcoholic beverages or beer are the principal commodities sold or handled.
- (4) Permit any prostitute to frequent the licensed premises or to solicit patrons for prostitution on the licensed premises.
- (5) Permit any disturbance of the peace or obscenity, or any lewd, immoral, or improper entertainment, conduct or practices.
- (6) Sell, offer for sale, possess, or permit the consumption on or about the licensed premises of any kind or type of alcoholic beverage, the sale possession of which is not authorized under his permit.
- (7) Employ or permit females, commonly known as “B Girls”, to solicit patrons for drinks and to accept drinks from patrons and receive therefore any commission or any remuneration in any other way.
- (8) Employ anyone under eighteen years of age when the sale or handling of alcoholic beverages constitutes the main business. However, females over that age may be employed as well as males. If the sale or handling of alcoholic beverages does not constitute the main business, an employee under the age of eighteen years shall not be permitted to handle, serve, or work with alcoholic beverages.
- (9) Fail to keep the licensed premises well lighted, and all outside windows and doors open to view from the sidewalk or outside.
- (10) Fail to keep the premises clean and sanitary.
- (11) Permit the playing of pool or billiards by any person under eighteen years of age, or permit such a person to visit or frequent the licensed premises, operating a pool or billiard hall.
- (12) Illegally sell, offer for sale, possess, or permit the consumption on or about the licensed premises of any kind or type of narcotics or habit forming drugs.
- (13) Accept food stamp coupons as payment for alcoholic beverages in violation of the provisions of Public Law 88-525 and Regulation 1600.2 (i) issued pursuant to this Section of the Federal Statute by the United States Secretary of Agriculture.

Violation of this section by a retail dealer’s agent, associate, employee, representative or servant shall be considered the retail dealer’s act for purposes of suspension or revocation of the permit.

Violation of this section is punishable as provided in R.S. 26:191 and is also sufficient cause for the suspension or revocation of the permit.

R.S. 26:76).
