The following ordinance was introduced by Mr. Dexter Callahan and duly seconded by Mr. Chad Vallo.

**ORDINANCE  
 2023-O-01**

**AN ORDINANCE REVISING AND RENAMING  
 ELECTION PRECINCT BOUNDARIES OF VERMILION PARISH  
 IN ACCORDANCE WITH  
 ACT 1420 OF THE 1997 LOUISIANA LEGISLATURE**

*WHEREAS*, Act Number 1420 of the Regular Session of Louisiana Legislature required the governing authority of each Parish of establish clearly definable and clearly observable boundaries of election precincts for the purpose of obtaining census data for reapportionment; and

*WHEREAS*, the existing Vermilion Parish election district precinct boundaries were amended to meet the requirements of R.S. §18:532B, which requires that each precinct shall be contiguous, compact area having clearly defined and clearly observable boundaries coinciding with visible features readily distinguishable on the ground such as designated highways, roads, streets, rivers and canals, and depicted on United States Bureau of Census base maps for the next decennial census, except where the precinct boundary is contiguous with the boundary of a Parish; and

*WHEREAS*, when the United States Bureau of Census decennial census were prepared for the 2020 Census, the precinct boundaries for certain election district had to be redefined to obtain an equitable apportionment plan for the Vermilion Parish Police Jury; and

*WHEREAS*, it is the desire of the Vermilion Parish Police Jury to amend the boundaries of their Precinct to coincide with the new boundaries as established with the apportionment plan of the Vermilion Parish Police Jury and to amend others to coincide with the most recent official map of the Parish of Vermilion, Louisiana which identified their road system by name rather than numbers.

***NOW, THEREFORE BE IT ORDAINED*** by the Vermilion Parish Police Jury as follows:

**Section 1.** In accordance with the provision of the Louisiana Election Code, and in particular those sections amended by Act 1420 of the 1997 regular Session of the Louisiana Legislature, the Vermilion Parish Police Jury for the Parish of Vermilion does hereby amend and re-establish and define the territorial limits of the following precincts within the Parish of Vermilion, State of Louisiana:

**Section 3.** Should any section of provision of this ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the ordinance as a whole or any part thereof, other than the part so declared unconstitutional or invalid.

**Section 4.** All ordinances or part of ordinances in conflict herewith or incompatible with the provisions of this ordinance are hereby replaced.



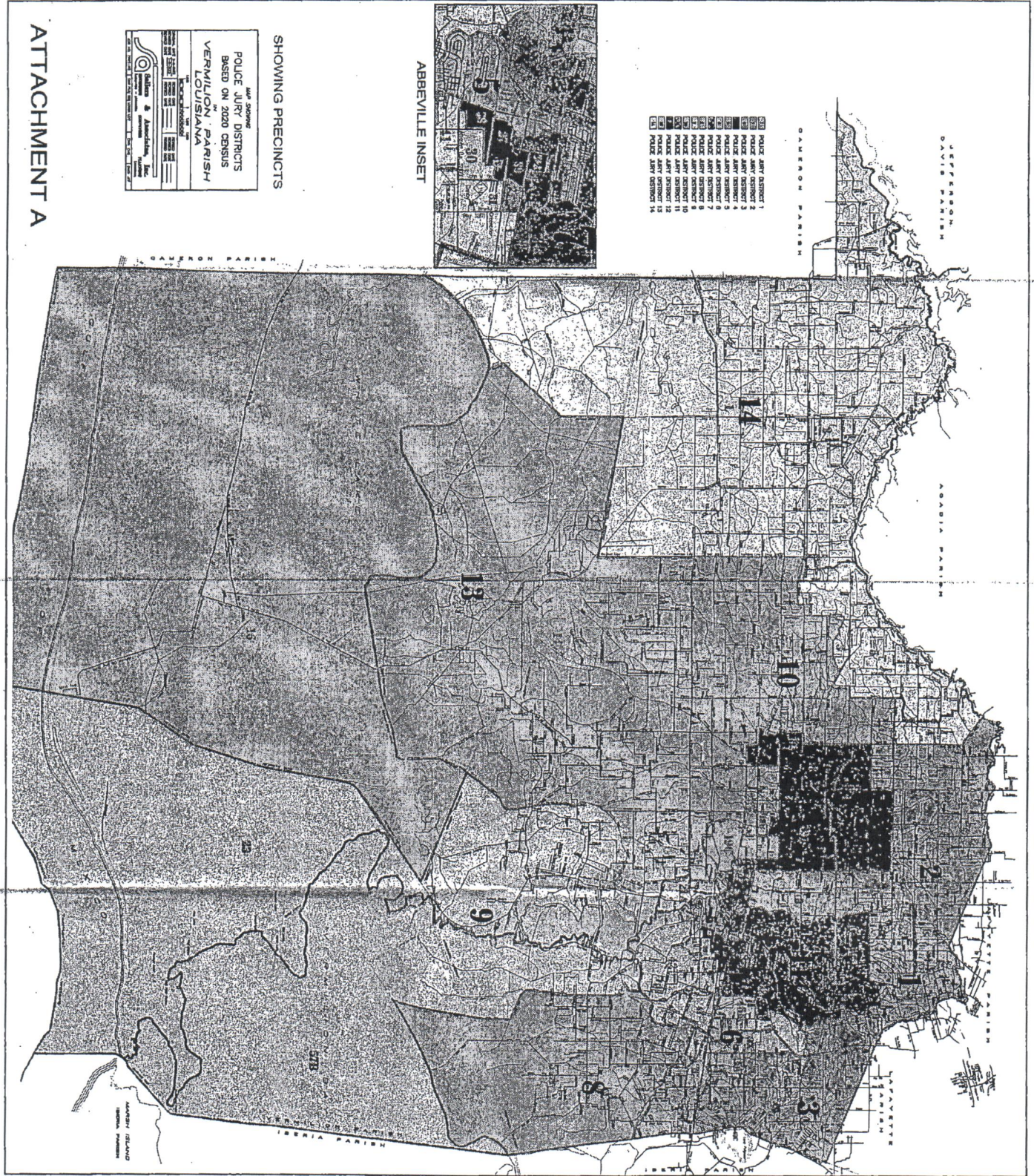
