ORDINANCE 2023-O-03

AN ORDINANCE REVISING CERTAIN ELECTION PRECINCT
BOUNDARIES OF VERMILION PARISH, PREVIOUSLY ESTABLISHED BY
ORDINANCE 2011-0-18 AND AMENDED BY ORDINANCE 2015-0-10,
PROVIDING FOR THE MERGER, CONSOLIDATION AND RELOCATION
OF PRECINCTS AS AUTHORIZED BY LOUISIANA REVISED STATUTE R.S.
18:532, 18:532.1, AND 18:532B(4)(a)(i)

WHEREAS, R.S. 18:532.1 allows for the merging of precincts within a parish, and

WHEREAS, other portions of R.S. 18:532, allow for the consolidation of precincts having less than 300 registered voters, and

WHEREAS, R.S. 18:532B(4)(a)(i), allows for an exemption for an unincorporated and geographically isolated area.

NOW, THEREFORE BE IT ORDAINED by the Vermilion Parish Police Jury that the following sections shall be authorized and approved:

Section 1. The following precincts shall be merged as detailed:

- Precinct 3 (8 Voters), located at Kaplan Elementary School, and Precinct 5 (427 Voters), located at Leleux Fire Department, are merged and designated as Precinct 5 and located at Leleux Fire Department.
- 2) Precinct 19B (26 Voters), located at Meaux Elementary School, and Precinct 20B (420 Voters), located at Kaplan High School, are merged and designated as Precinct 20B and located at Kaplan High School.
- 3) Precinct 21 (112 Voters), located at Public Works Building, and Precinct 19C (324 Voters), located at Meaux Elementary School, are merged and designated as **Precinct 21** and located at Public Works Building.
- 4) Precinct 22 (296 Voters), located at Cecil Picard Elementary School, and Precinct 25A (282 Voters), located at Cecil Picard Elementary School, are merged and designated as **Precinct 22** and located at Cecil Picard Elementary School.
- 5) Precinct 27 (81 Voters), located at Cecil Picard Elementary School, and Precinct 26 (370 Voters), located at Cecil Picard Elementary School, are merged and designated as **Precinct 26** and located at Cecil Picard Elementary School.
- 6) Precinct 31 (36 Voters), located at Live Oak Masonic Lodge

- #193, and Precinct 37 (996 Voters), located at New Parish Government Office Complex, are merged and designated as **Precinct 37** and located at New Parish Government Office Complex.
- Precinct 43 (82 Voters), located at Abbeville High School, and Precinct 42 (903 Voters), located at Abbeville High School, are merged and designated as **Precinct 42** and located at Abbeville High School.
- 8) Precinct 45B (55 Voters), located at Vermilion Parish Police Jury Area Barn 1, and Precinct 51 (728 Voters), located at Erath Community Center, are merged and designated as Precinct 51 and located at Erath Community Center.
- Section 2. The following Precincts shall be consolidated and shall be manned by one set of commissioners handling all books:
 - 1) Precinct 7 (15 Voters) and Precinct 7B (383 Voters), both located at Indian Bayou/Andrew Fire Department.
 - 2) Precinct 4 (128 Voters) and Precinct 7A (406 Voters) and Precinct7C (56 Voters), all located at Indian Bayou/Andrew Fire Department.
 - 3) Precinct 12 (714 Voters) and 20A (228 Voters), both located at Kaplan High School.
 - 4) Precinct 19A (519 Voters), Precinct 19 (733 Voters), and Precinct 20 (66 Voters), all located at Meaux Elementary School.
 - 5) Precinct 21 (122 Voters), Precinct 21A (338 Voters) and Precinct 41 (136 Voters), all located at the Public Works Building.
 - 6) Precinct 25 (1620 Voters) and Precinct 22 (580 Voters), both located at Cecil Picard Elementary School.
 - 7) Precinct 26 (370 Voters) and Precinct 26A (601 Voters) and Precinct 26B (421 Voters), all located at Cecil Picard Elementary School.
 - 8) Precinct 32 (364 Voters), Precinct 34 (623 Voters) and Precinct 34A (309 Voters), all located at Gulf Area LTC (BCS Center).
 - 9) Precinct 30 (15 Voters) and Precinct 37 (996 Voters), both located at New Parish Government Office Complex.
 - 10) Precinct 36A (273 Voters) and Precinct 39 (440 Voters), both located at J.H. Williams Middle School.

- 11) Precinct 45 (75 Voters), and Precinct 45A (389 Voters), both located at Vermilion Parish Police Jury Area 1 Barn.
- 12) Precinct 46 (575 Voters), Precinct 46C (283 Voters), both located at the New Parish Government Office Complex.
- 13) Precinct 46D (290 Voters) and Precinct 46E (828 Voters), both located at Herod Elementary School.
- 14) Precinct 46B (351 Voters) and Precinct 47 (202 Voters), both located at Herod Elementary School.
- 15) Precinct 49A (108 Voters) and Precinct 49B (272 Voters) and Precinct 49C (118 Voters), all located at Leblanc Elementary School.
- 16) Precinct 56 (21 Voters) and Precinct 57A (865 Voters) and Precinct 57B (147 Voters), all located at Henry Fire Station.
- Section 3. The following Precinct is considered to fall under the exemption provision of R.S. 18:532B(4)(a)(i), an unincorporated and geographically isolated area:
 - 1)Precinct 16 (136 Voters), located at the Pecan Island Fire Station.

Section 4. The following Precincts will be left as is:

Precinct 1 (1173 Voters), Precinct 2 (803 Voters), Precinct 6 (754 Voters), Precinct 3 (356 Voters), Precinct 9 (856 Voters), Precinct 10 (667 Voters), Precinct 11 (679 Voters), Precinct 14 (1498 Voters), Precinct 16 (119 Voters), Precinct 17 (556 Voters), Precinct 18 (1297 Voters), Precinct 23 (802 Voters), Precinct 24 (959 Voters), Precinct 28 (883 Voters), Precinct 29 (787 Voters), Precinct 35 (719 Voters), Precinct 38 (607 Voters), Precinct 40 (997 Voters), Precinct 44 (608 Voters), Precinct 49 (2074 Voters), Precinct 50 (860 Voters), and Precinct 53 (1659 Voters).

- Section 5. The revised list of polling locations within the Parish of Vermilion, State of Louisiana shall be as follows in ATTACHMENT A.
- Section 6. Should any section or provision of this ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the ordinance as a whole or any part thereof, other than the part so declared unconstitutional or invalid.
- Section 7. All ordinances or part of ordinances in conflict herewith or incompatible with the provisions of this ordinance are hereby replaced.
